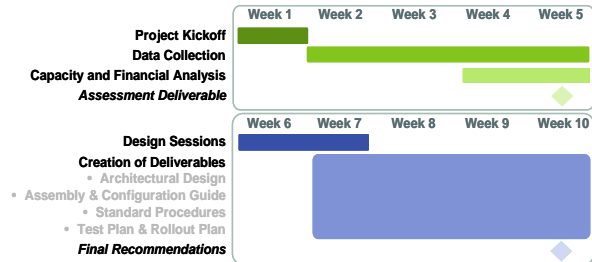
## Target Audience
